# HOME REPAIR AND UTILITY FINANCIAL ASSISTANCE

#### **Homestead Exemption**

**About the program**: Homeowners ages 65 and older, people who are permanently disabled, and surviving spouses of public service officers killed in the line of duty regardless of age, may be eligible for a reduction in their property tax. The exemption takes the form of a credit on property tax bills. The exemption for senior and disabled persons allows eligible homeowners to exempt the first \$25,000 of their home's appraised value from taxation. The enhanced homestead exemption for disabled veterans and for surviving spouses of public service officers killed in the line of duty allows eligible homeowners to exempt the first \$50,000 of their home's appraised value from taxation.

**Requirements:** Own and occupy the home as their primary place of residence as of January 1 of the year for which they apply. For the current 2022 application period, the maximum allowed is \$34,600 total income in 2021.


